

AIRCRAFT RENTAL & TERMS OF USE AGREEMENT

<u>Aircraft Subject to Aircraft Rental Agreement</u>: Any and all aircraft owned, leased or otherwise operated and offered for rental by ANGEL AVIATION INC.

<u>Acceptance of Aircraft by Renter</u>: Renter will inspect the aircraft prior to acceptance and shall immediately notify ANGEL AVIATION INC. of any discrepancies, damage or other condition relating to the rental of the aircraft. If the Renter fails to provide such notice before accepting the aircraft, the Renter will be conclusively presumed to have accepted the aircraft in a satisfactory condition. Renter agrees to conduct a full preflight inspection in accordance with the manufacturer's guidelines and to verify that it is airworthy prior to operation.

I. Flight Operations

- a) There will be NO landing on unapproved runways, (including but not limited to: sand, dirt, gravel, grass, etc.) except in emergencies or with prior authorization from ANGEL AVIATION INC. personnel.
- b) Renter will comply with all Federal Aviation Regulations (FAR's) and rules.
- c) Renter will operate aircraft in compliance with the procedures and limitations in the Pilot-Operating Handbook (POH).
- d) Renter will use sound judgment while operating the aircraft.
- e) Renter will not give or receive flight instruction from non-ANGEL AVIATION INC. personnel.

II. Pilot Requirements

- a) Renter must have current FAA medical and appropriate pilot certificates.
- b) Renter will meet FAA currency requirements for type of flight they are conducting.
- c) Renter must receive an aircraft checkout from an approved flight instructor by ANGEL AVIATION INC.
- d) If renter has not flown with ANGEL AVIATION INC. within 90 days, another checkout must be completed unless otherwise specified by ANGEL AVIATION INC.
- III. Maintenance and Return of Aircraft to ANGEL AVIATION INC.



AIRCRAFT RENTAL & TERMS OF USE AGREEMENT

- a) Renter will be charged \$500 for the replacement of damaged tires (i.e. flat spots).
- b) Renter will be charged for any damage due to negligence use of certain items (i.e. sun visors, headrests, but not limited to these items).
- c) Renter will remove all trash from aircraft and return aircraft in the same manner with which it was taken. If the aircraft is left disordered or professional cleaning is required, renter will be charged and billed accordingly.
- d) Renter will notify ANGEL AVIATION INC. personnel as soon as possible if involved in an aircraft accident or incident.
- e) Renter will notify ANGEL AVIATION INC. personnel if there is a maintenance problem at or away from ANGEL AVIATION INC's rental location.
- f) Renter will not leave the aircraft until arrangements are made with ANGEL AVIATION INC. personnel if there is a maintenance problem away from ANGEL AVIATION INC's rental location.
- g) Renter will notify ANGEL AVIATION INC. as soon as possible anytime a rental aircraft cannot be returned by the scheduled time. Failure to do so may incur additional charges.

IV. Payment

- a) Payment for flight time will be based on the FLIGHT HOBBS meter and is due either prior to conducting the flight or immediately following the return of the rental aircraft.
- b) Renter must have a Credit Card on file, prior to aircraft rental, to cover any and all damages. (Refer to Section V-a)

V. Liability for Damage to Aircraft

a) Renter agrees to pay ANGEL AVIATION INC. for any damage or loss to a rental aircraft, including but not limited to loss of use, due to Renters negligence or misuse or any other cause occurring during the period the aircraft is in the possession and care of the Renter. If the Renter has rental aircraft insurance, ANGEL AVIATION INC. will collect any sums due directly from the insurance carrier.
